Corrections Director. During his interview, he stated as the "PREA Coordinator he has sufficient time and authority to develop, implement, and oversee agency efforts to comply with the PREA standards".

(c) The PCDC only operates one facility.

- (a) The PCDC has developed and documented the staffing plan and has adopted generally accepted detention and correctional practices. Standards are reviewed annually and changes are made as necessary. Nebraska State statute mandates that female staff is on duty at all times. There have been no judicial findings of inadequacy nor have there been any findings of inadequacy from Federal investigative agencies. The PCDC has not received any findings of inadequacy from internal or external oversight bodies. The PCDC conducts an annual risk assessment which includes a review of blind spots within the facility. The information is used to determine where additional supervision is necessary, where supervisory coverage is necessary and where additional cameras may be needed. The PCDC monitors the composition of the inmate population on a daily basis and uses this information to justify staffing for coverage of male, female and special population inmates. The PCDC requires supervisors (Sgt. or Corporal) to visit each housing unit once per shift.
- (b) The PCDC does not deviate from the staffing plan. This was discussed and confirmed during the interview with the PREA Coordinator.
- (c) The PCDC has not deviated from the staffing plan in the last 12 months.
- (d) PCDC Policy addresses that staff is prohibited from alerting other staff that a supervisory is conducting rounds are occurring. The PCDC provided copies of PREA Spot Checks Logs with the pre-audit documentation which shows this as a regular practice.

- (a) PCDC policy states staff will not conduct cross-gender strip searches or cross gender visual body cavity searches except in exigent circumstances or when performed by medical practitioners. Per policy, all strip searches will be documented. There were ten random staff interviews conducted and staff reiterated that they have not conducted cross-gender strip searches or cross gender visual body cavity searches. Random inmate interviews also confirmed they have not been strip searched or received a visual body cavity search by a staff member of the opposite sex. One transgender inmate was interviewed and indicated they were asked about their preference of gender to conduct searches.
- (b) Interviews with random female inmates stated that "pat down searches are always conducted by female staff and they have access to regularly available programming which includes out of cell opportunities". During the on-site there was a number of female staff available to conduct searches. At least one female staff member is assigned to the facility at all times.
- (c) The facility documents all strip searches however PCDC policy states staff will not conduct cross-gender strip searches or cross gender visual body cavity searches except in exigent circumstances or when performed by medical practitioners.
- (d) PCDC policy states the facility implements policies and procedures that enable inmates to shower, perform bodily functions, and change clothing without non-medical staff of the opposite gender viewing their breasts, buttocks, or genitalia, except in exigent circumstances or when such viewing is incidental to routine cell

checks. PCDC Policy requires staff to announce their presence when entering housing units with inmates of a different gender. Staff interviews reiterated that they announce themselves or will announce staff of a different gender prior to entering the housing unit.

- (e) PCDC policy states that inmates will not be searched or physically examined for the sole purpose of determining the genital status. If the inmate's genital status is unknown, the PCDC will initiate conversation with the inmate in a professional manner in a private setting in order to preserve confidentiality. Transgender inmate interviews indicated they were not physically examined for the sole purpose of determining the genital status.
- (f) PCDC policy states that unless an emergency or other special situation exists, pat searches should be conducted by staff of the same gender as the inmate. All staff is trained how to conduct searches of transgender and intersex inmates in a professional manner and in the least intrusive manner possible that is consistent with security needs.

- (a) The PCDC is responsible for administrative investigations and follows a uniform evidence protocol that maximizes the potential for obtaining usable physical evidence. All criminal investigations are referred to the Platte County Sheriff's Office (PCSO) for investigation. Random staff interviews show staff are trained and understand their responsibilities to preserve, collect and properly handle evidence.
- (b) PCDC protocol is appropriate for youth; however, the PCDC does not generally house youthful offenders.
- (c) The PCDC offers all victims of sexual abuse access to forensic medical examinations, whether at an outside facility, without financial cost, where evidentiary or medically appropriate. Interviews with the PREA Coordinator and Medical staff reiterated that all victims of sexual abuse are offered forensic examinations. Forensic medical examinations are completed at Columbus Community Hospital by qualified Sexual Assault Forensic Examiners (SAFEs) or Sexual Assault Nurse Examiners (SANEs).
- (d) The PCDC has an agreement with Center for Survivors and Victims Assistance to provide the victim with a victim advocate.
- (e) Interviews conducted with the PREA Coordinator reiterated that as requested by the victim, victim advocate, agency staff member, or community-based organization the victim will receive support through the forensic medical examination process and

investigatory interviews. The victim advocate may also provide on-going emotional support, crisis intervention, and referrals for other services

- (f) This provision is Not Applicable; the PCDC is responsible for administrative investigations and refers all criminal matters to the Platte County Sheriff's Office (PCSO).
- (g) The auditor is not required to audit this provision
- (h) This provision is Not Applicable; the agency refers these services to Center for Survivors or Victims Assistance for access to a victim advocate.

Investigations involving staff will be investigated by the Nebraska State Patrol (NSP). The PREA Coordinator is responsible for administrative investigations. Interviews conducted with the PREA Coordinator confirmed all administrative and criminal investigation is completed properly.
- (b) The PCDC has a policy and practice in place that ensures that allegations of sexual abuse or sexual harassment are referred for investigation. The PREA Coordinator will receive the allegations and conduct administrative investigations. Allegations that involve criminal behavior are referred to the Platte County Sheriff's Office (PCSO) for investigation. The PREA Coordinator will assist the PCSO with the investigation as required.

The PCDC has its PREA Policy on their website (https://plattecounty.net/pdfs/detention/PREA.pdf) stating that all inmates have the right to be safe from sexually abusive behavior. There policy discusses that jail staff investigate all allegations and the allegations that appear to be criminal will be investigated by the LCSO or NSP.

The PCDC documents all referrals to the PCSO. The PREA Coordinator is responsible for completing the investigation log which includes a chronological order of events in the investigation.

- (c) The information on the website is clear that LCSO will investigate allegations that may result criminal charges and the agency address and phone is provided as well.

- (a) The PCDC provides all staff with training which includes their zero-tolerance policy, how to fulfill their responsibilities under agency sexual abuse and sexual harassment prevention, detection, reporting, and response policies, inmates' right to be free from sexual abuse and sexual harassment, the right of inmates and employees to be free from retaliation for reporting abuse and all other components of this standard.
- (b) PCDC staff receives training tailored to the gender of the inmates, the facility houses male and female inmates and training records reviewed demonstrated a distinction in the training. All staff receives this training regardless of whether or not they are reassigned from another facility.
- (c) All current employees who have contact with inmates have received training. A review of the staff training records and random staff interviews confirm training was received.
- (d) The PCDC has completion reports which verify they have received the training and understand the training they have received. Upon completion of the lesson plan, staff is required to complete a test over the material. Staff interviews confirmed this process.

- (a) The PCDC ensures that all volunteers and contractors who have contact with inmates have been trained on their responsibilities under the agency's sexual abuse and sexual harassment prevention, detection, and response policies and procedures. All volunteers and contractors are provided information based on the level of services they provide and the level of contact that they will have with the inmates. Interviews conducted confirmed that volunteers and contractors received this information prior to entering the facility.
- (b) All volunteers and contractors who have contact with inmates have been notified of the agency's zero-tolerance policy regarding sexual abuse and harassment. Volunteers and contractors are informed how to report such incidents. The level and type of training provided to volunteers and contractors is based on the services they provide and level of contact they have with inmates and their training is tailored during orientation.
- (c) The PCDC maintains documentation confirming that volunteers and contractors understand the training they have received. Upon receipt of the PREA information, volunteers and contractors are required sign and acknowledge they understand the material.

Investigator interviews confirmed they have received additional training in accordance with their job responsibilities.
- (b) Specialized training includes techniques for interviewing sexual abuse victims, the proper use of Miranda and Garrity warnings, sexual abuse evidence collection in confinement settings and the criteria and evidence required to substantiate a case for administrative action or prosecution referral. Investigators were knowledgeable about the training they received.
- (c) The PCSO maintains documentation that investigators have completed the required specialized training in conducting sexual abuse investigations.

The training also includes; how to preserve physical evidence of sexual abuse, how to respond effectively and professionally to victims of sexual abuse and sexual harassment and how and to whom to report allegations or suspicions of sexual abuse and sexual harassment.
- (b) The portion of the standard is Not Applicable as all forensic exams are conducted at Columbus Community Hospital. Staff interviews confirmed this information.
- (c) The PCDC maintains documentation that staff has received the training referenced in this standard either from the agency or elsewhere. Training records were reviewed and compliance has been met.

- (a) The PCDC assesses all inmates during admission for their risk of being sexually abused by other inmates or sexually abusive toward other inmates. The auditor observed this process during the onsite visit.
- (b) Interviews conducted with Booking staff indicated the intake screenings are typically completed within two hours of admission but definitely take place within 72 hours of arrival at the facility. Random inmate interviews confirmed this process is being completed.
- (c) The PREA screening assessments are conducted using an objective screening tool (PCDC PREA Screening Checklist) which was verified by the auditor during the onsite visit.
- (d) The intake screening tool at the PCDC considers the following criteria to assess inmates for risk of sexual victimization: whether the inmate has a mental, physical, or developmental disability, assess inmates for risk of sexual victimization, the age of the inmate, the physical build of the inmate, whether the inmate has previously been incarcerated, whether the inmate's criminal history is exclusively nonviolent, whether the inmate has prior convictions for sex offenses against an adult or child, whether the inmate is or is perceived to be gay, lesbian, bisexual, transgender, intersex, or gender nonconforming, has previously experienced sexual victimization, the inmate's own perception of vulnerability and whether the inmate is detained solely for civil immigration purposes.
- (e) When assessing inmates for risk of being sexually abusive, the PCDC initial PREA

screening checklist considers the following, prior acts of sexual abuse, prior convictions for violent offenses, history of prior institutional violence or sexual abuse.

- (f) Within a set time period not more than 14 days from the inmate's arrival at the facility, PCDC staff will reassess the inmate's risk of victimization or abusiveness based upon any additional, relevant information received by the facility since the intake screening.
- (g) The PCDC reassesses an inmate's risk level when warranted due to a: referral, request, incident of sexual abuse and receipt of additional information that bears on the inmate's risk of sexual victimization or abusiveness.
- (h) PCDC Policy states that inmates may not be disciplined for refusing to answer, or for not disclosing complete information in response to the risk screening questions. Interviews conducted with staff reiterated that inmates would be not disciplined for refusing to answer the screening questions.
- (i) The PCDC has implemented appropriate controls on the dissemination within the facility of responses to questions asked pursuant to this standard in order to ensure that sensitive information is not exploited to the inmate's detriment by staff or other inmates. That information is kept in a restricted area and only authorized staff can access the information.

- (a) The PCDC uses information from the risk screening required by § 115.41, with the goal of keeping separate those inmates at high risk of being sexually victimized from those at high risk of being sexually abusive, to inform: housing assignments, bed assignments, work assignments, education assignments and program assignments. Interview with the PREA Coordinator and random staff responsible for risk screening confirmed how the risk screening is utilized.
- (b) The PCDC makes individualized determinations about how to ensure the safety of each inmate based on information gathered during the risk screening. Random staff interviews confirmed that all information gathered is used to ensure the safety of each inmate.
- (c) When deciding whether to assign a transgender or intersex inmate to a facility for male or female inmates, PCDC Staff determines the inmates housing assignment after review of the inmate records, assessments and an interview with the inmate.
- (d) PCDC policy requires that placement and programming assignments for each transgender or intersex inmate is reassessed monthly.
- (e) PCDC staff meets with transgender or intersex individuals to discuss the inmate's own views with respect to his or her own safety and will give serious consideration when making facility and housing placement decisions and programming assignments.
- (f) Transgender inmates at the PCDC are given the opportunity to shower separately

from other inmates.

(g) The PCDC does not place lesbian, gay, bisexual, transgender, or intersex inmates in dedicated facilities, units, or wings solely on the basis of such identification or status, unless such placement is in a dedicated facility, unit, or wing established in connection with a consent decree, legal settlement, or legal judgment for the purpose of protecting such inmates. The PCDC does not have a dedicated unit or wing solely on the basis of identification or status.

Interviews with the PREA Coordinator and Random Staff confirmed this practice.
- (b) The Inmates placed in segregated housing have access to programs, privileges, education, and work opportunities.
- (c) The PCDC does not assign inmates at high risk of sexual victimization to involuntary segregated housing, once information is gathered from the risk screening tool it is assessed by supervisory staff to determine proper housing. The PREA Coordinator and random staff confirmed this process.
- (d) If an inmate is requesting PC the inmate will be interviewed and their request will be documented and forwarded to the PREA Coordinator. The PREA Coordinator will review the request and document their recommendations including why alternative means of separation could not be arranged.
- (e) The PCDC has reported that there are no cases of an inmate being placed in involuntary segregation because he/she is at high risk of sexual victimization. PCDC Policy states that the facility reviews whether there is a continuing need for separation from the general population every 7 days.

The PCDC reported zero (0) inmates at risk of sexual victimization who were held in involuntary segregated housing.

PCDC does not require an inmate to use any informal grievance process, or to otherwise attempt to resolve with staff, an alleged incident of sexual abuse and ensures that an inmate who alleges sexual abuse may submit a grievance without submitting it to a staff member who is the subject of the complaint, and such grievance is not referred to a staff member who is the subject of the complaint. PCDC issues a final agency decision on the merits of any portion of a grievance alleging sexual abuse within 90 days of the initial filing of the grievance Third parties, including fellow inmates, staff members, family members, attorneys, and outside advocates, are permitted to assist inmates in filing requests for administrative remedies relating to allegations of sexual abuse, and are also be permitted to file such requests on behalf of inmates. PCDC has established procedures for the filing of an emergency grievance when the inmate is subject to a substantial risk of imminent sexual abuse. After receiving an emergency grievance alleging a substantial risk of imminent sexual abuse, PCDC immediately forwards the to a level of review at which immediate corrective action is taken, and provides an initial response within 48 hours, and issues a final agency decision within 5 calendar days. The initial response and final agency decision documents PCDC's determination whether the inmate is in substantial risk of imminent sexual abuse and the action taken in response to the emergency grievance. The PCDC may discipline a detainee for filing a grievance related to alleged sexual abuse only where it can be demonstrated that the inmate filed the grievance in bad faith.

PCDC has not received any detainee grievances regarding a PREA related incident in the past twelve (12) months.

Interviews conducted with staff showed they understood their duty to report any instances or suspected instances of sexual abuse. Staff was also aware of their duty not to discuss the allegations.

The staff was able to clearly articulate during the interviews the importance of keeping the information confidential.

The PCDC has designated the PREA Coordinator to conduct the monitoring.
- (b) The PCDC has multiple protection measures, such as housing changes or transfers for inmate victims or abusers, removal of alleged staff or inmate abusers from contact with victims, and emotional support services for inmates or staff that fear retaliation for reporting sexual abuse or sexual harassment or for cooperating with investigations.
- (c) The PREA Coordinator will for at least 90 days following a report of sexual abuse, monitor the conduct and treatment of inmates or staff who reported the sexual abuse and of inmates who were reported to have suffered sexual abuse to see if there are changes that may suggest possible retaliation by inmates or staff, and shall act promptly to remedy any such retaliation. The PREA Coordinator also monitors any inmate disciplinary reports, housing, or program changes, or negative performance reviews or reassignments of staff. The PREA Coordinator may continue such monitoring beyond 90 days if the initial monitoring indicates a continuing need.
